<u>Town & Country Planning Act 1990, Proposed Public Path Diversion Order of Footpath AX 32/13 in the parish of Burnham and Highbridge</u>

An application has been received to divert the above footpath, as shown on the attached plan. The existing route of the above- named footpath followed by the proposed site of the new footpath is described as follows: -

Existing Route to be stopped up:

Part of footpath ref AX 32/13 in the parish of Burnham and Highbridge at 150 Berrow Road, Burnham on Sea, TA8 2PN from point A (Nat Grid Map Ref. 330423 150936) in a generally easterly direction to point B (Nat Grid Map Ref 330454 150931), a distance of approximately 31 metres then from point B in a generally northerly direction to point C (Nat Grid Map Ref 330479 150992) a distance of approximately 58 metres.

Proposed New Route:

From point A (Nat Grid Map Ref 330423 150936) on footpath ref AX 32/13 in the parish of Burnham and Highbridge at 150 Berrow Road, Burnham on Sea, TA8 2PN in a generally north easterly direction to point D (Nat Grid Map Ref. 330490 150973, a distance of approximately 82 metres, then from point D in a generally northerly direction to point E (Nat Grid Map Ref. 330489 150989), a distance of approximately 14 metres and then from point E in a generally westerly direction to point C (Nat Grid Map Ref 330479 150992) a distance of 12 metres.

The width of the path will be a minimum of 2m.
