**Proposal:** Crown reduce 3m Norway Maple (TPO Ref T54) and remove central stem. Crown lift Sycamore (TPO Ref T47) to 4m and reduce extended branch by 1.5m to provide clearance over roof and streetlight. Crown lift Sycamore (TPO Ref T50) to 4m above ground level and remove



2 lower limbs overhanging Bowling Club building. Crown lift Purple Beech (TPO Ref T42) to 3.5m above ground level by removal of secondary growth. Crown lift Cherry (CA Ref T348) to 2.5m over footpath. Pollard Horse Chestnut (TPO Ref T41) to previous reduction points. Crown lift Common Lime (TPO Ref T40) to 3.5-4m above ground level and reduce extended branch limb over bench by 3-4m and reduce extended limb over boundary by 2-3m. Remove epicormic/stem growth. Crown Lift Beech (TPO Ref T43) to 3m and reduced extended limb towards building. Crown lift secondary growth of Common Beech (TPO Ref T39) back to previous reduction points. Pollard 2No.Common Lime (TPO Refs T38 & T34) to previous reduction points. Remove epicormic/stem growth of Horse Chestnut (TPO Ref T35). Crown reduce extended limbs of Purple Beech (TPO Ref T33) over grass by 3-4m. Pollard 2 No. Common Lime (TPO Refs T32 & T30) to previous reduction points and remove epicormic growth. Pollard Sycamore (TPO Ref T31) to previous reduction points. Crown lift Hornbeam (TPO Ref T36) to 3m above ground level and remove branch to west. Crown lift Common Lime (TPO Ref T27) to 4m above ground level and thin crown by 20%. Crown lift Cherry (CA Ref T367) to 2.5m over footpath, reduce crown height/spread by 1-2m and reduce extended branch low limbs towards path. Remove epicormic/stem growth and hanging branch at 4m. Crown lift Purple Beech (TPO Ref T24) to 3.5m above ground level. Fell 1No. False Acacia (TPO Ref T20). Remove branch rubbing against adjacent Pine of Sycamore (TPO Ref T73). Crown reduce extended branch of Sycamore (TPO Ref T68) to provide 2m clearance property side. Pollard 3No. Plane (TPO Refs T65, T60, T64) to previous reduction points. Crown lift Plane (TPO Ref T62) to 4m above ground level and reduce extended lower branches towards road. Crown clean and lift Common Lime (TPO Ref T63) to 4m above ground level. Pollard 1No. Plane (TPO Ref T61) to previous pruning points, remove epicormic growth and dead limb on path side. Pollard 1No. Common Lime (CA ref T390) previous pruning points, remove epicormic growth and hanging branch over footpath. Crown lift Common Lime (TPO Ref T57) to 3-3.5m above ground level. Crown reduce height/spread by 2-3m of Sycamore (TPO Ref T59) to provide clearance of streetlight and buildings. Crown lift Common Beech (TPO Ref T56) to 4m above ground level, thin and reduce extended branches by up to 3-4m to suitable reduction points. Crown clean and crown lift Deodar Cedar (CA ref T399) to 2.5-3m above ground level.
