I am writing to you because I have been advised this is get best route. My mother lives on Marine drive and utilises the Apex park every day as do many people. It's a brilliant community asset and it one that brings so many people in to Burnham on Sea.

The reason for my email is that Marine drive has become in credibly dangerous round to cross in particularly if you need to near the Apex park itself.
