Premises address: Rainbow Lounge, 36 High Street, Burnham on Sea

**Resolved** to object. The no-obstruction condition is a condition that the licence must not have the effects set out in section 3(6) of the 2020 Act. When determining whether furniture constitutes an unacceptable obstruction in light of the no-obstruction condition, the provisions require that local authorities consider the needs of disabled people.

Section 3.2 of Inclusive Mobility sets out a range of recommended widths which would be required, depending on the needs of particular



pavement users, but is clear that in most circumstances 1500mm clear space should be regarded as the minimum acceptable distance between the obstacle and the edge of the footway, which the committee feel will not be met.
