Memorials - No memorials over 2 feet in height from the ground level shall be erected until six months from the date of the Interment. The lease for the permit is for the duration of the grave lease. All

A Headstone or Cross not exceeding 4ft in height, base not exceeding 3ft {120cm x 90cm)	£195
Brent Road Cemetery Garden of Rest - New Section. The base plinth is already installed measuring 24" x 24". A Tablet must not exceed 18" x 18"	£160
Highbridge Cemetery- A Tablet for the Garden of Rest, Open Book or Heart-Stone tablets must be erected with the shortest measurement at the head and foot of the plot. The base plinth must not exceed 24" x 18"
